- Log for documenting quality control (QC) procedures.
  - ACR / Accreditation Phantom test
  - Repeat analysis procedure
  - Compression test
  - Mechanical / visual inspection
  - Contrast-to-Noise Ratio / Signal-to-Noise Ratio (CNR / SNR)
  - Full (flat) field artifact test
  - Monitor QC for reading/review workstation
  - Monitor QC for acquisition workstation

- Log for documenting performance of breast imaging procedures
  - Standard view mammography (CC & MLO)
  - Other breast imaging exams
    - Magnification views
    - DBT &/or spot compression
    - Exaggerated CC &/or Rolled view &/or Tangential &/or Cleavage view
    - True laterals
    - Implants
    - Surgically altered breast
    - Stretcher / wheelchair patient
    - Male patient
  - Interventional procedures
    - Needle, seed and/or radiofrequency localization
